UMnumzana Goqa uvele kulenkundla wayebekwe ityala lokudlwengula. Waye wafumaniseka enetyala uMnumzana Goqa emva kokuba ityala lakhe lithethwe yinkundla yaseRegional Court, yangweba iminyaka elishumi. UMhlekezi Goqa namhlanje uvela kule nkundla phambi kwethu efake isibheni malunga nesigwebi sakhe seminyaka elishumi.

Malunga nombi wokuba efumaneke enetyala wagwetywa egwetywelwa ukudlwengula asikho isibheni. Silapha ke sizijaji, mna noMhlekezi lo uZondi esichophele kunye esisibheni, siye sayifunda yonke irekhodi, sanelisekile yinto yokuba lomhlekezi wadlwengula nyani. Naxa sijonga ijudgment yenkundla yeRegional Court, icacile loo nto ukuba ijudgment isemgangathweni iyabonisa into yokuba wadlwengula umhlekezi. Ngokucacileyo ngoko ke asinakho ukuthetha ngento yokuba wadlwengula okanye akazange adlwengule kuba icacile wadlwengula.

Inye qha into esinokuthetha ngayo namhlanje, imalunga nesentence. Mhlekezi, ityala lokudlwengula yinto embi kakhulu kwaye imasikizi. Xa sijonga indlela inkundla le yeRegional Court eyijonge ngayo yonke lento loo nto icacile ukuba noko bayijonge kakuhle, nesigwebi sakhe seminyaka elishumi noko asinakuthi asifanalekanga. Kaloku asinakuvele sithi hayi esi sigwebi sikhulu okanye sincinci, okanye thina asisithandi. Ngokomthetho sisenokuphazamisana

nesigwebo xa singafanalekanga, oko kukuthi sisikhulu kakhulu, okanye sisincinci kakhulu. Xa usijonga esisigwebo seminyaka elishumi kwityala lokudlwengula noko akubonakali singafanalekanga.

Njengokuba uRumpff J wayetshilo kwityala lika **S v Zinn 1969 (2) SA 537 (A)**, at 541 F “in trivial cases indeed Judges ought to be more inclined to mildness, but in more serious cases to follow the severity of the laws with a certain moderation of generosity”. Kwaye uHolmes JA yena kwityala lika **S v V 1972 (3) SA 611 (A)** wathi “Punishment should fit the criminal as well as the crime, be fair to the accused and the society, and be blended with a measure of mercy; ... The element of mercy, a hallmark of civilised and enlightened administration, should not be overlooked, lest the Court be in danger of reducing itself to the plane of the criminal...”

Ukudlwengula nokuhlukumeza abasetyhini akwamkelekanga. Okulindelekileyo emadodeni kukukhusela amalungelo abafazi. Inkundla noko iye imbonelele ummangalelwa malunga nesigwebo xa imeko ivuma. Naxa kunjalo, inkundla ayinakumthethelela umntu odlwengule umfazi kwimeko ezimasikizi.

Ngokokwamukubona isibheni sakho malunga nesigwebo (isentence) noko asinakuphumelela kulenkundla. Nasi isigwebo senkundla, isibheni sakho siyasichitha.
